YOUR KEYNOTE SPEAKER MICHAEL BENENATI



An EMS provider since 1977, Michael has been involved in many EMS delivery systems including as a volunteer EMT, Paramedic, Officer, and Board member in a not-for-profit transporting Advanced Life Support (ALS) agency and later as a career Officer. Michael has worked in a variety of other settings including collegiate, volunteer fire, commercial ambulance, and a combination Fire District providing ALS Transport. Many of these roles have been in leadership positions. His contributions have been at the local, county, regional and state level. Throughout his career Michael has developed several operational plans and documents to include 911 Center Standard Operating Guidelines, County EMS Mutual Aid Plans, County MCI Plans, including Ulster County's response to the National Disaster Medical System (NDMS) Operation Enduring Freedom & Operation Iraqi Freedom, the Woodstock '94 concert and the New Paltz Emergency Preparedness Plan. Michael represented the EMS community in the implementation of the Ulster County Enhanced 9-1-1 system and Emergency Medical Dispatch (EMD) programs. He continues to teach EMD and works part-time as a telecommunicator. Michael served as the Chair of the NYSEMSCO appointed EMS Sustainability Technical Advisory Group (TAG) which authored the NYS 2023 Evidence Based EMS Agenda for the Future. Most recently he served as Vice-Chair on the New York State Rural Ambulance Services Task Force. Michael is a member of EMS Task Forces in Ulster and Dutchess Counties. For several years he served as Chair of the Hudson Valley Regional EMS Councils Protocol Committee. Michael has been the recipient of Advanced Life Support Provider of the year for Ulster County, the Hudson Valley Regional EMS Council and New York State. In 2023 he was the recipient of Harriet C. Weber EMS Leadership Award in Dutchess County, the Hudson Valley Region and New York State. In 2023 Michael also received the Commissioner of Health's Award of Excellence in EMS Activities and NYSVARA EMS Leadership Award. Most recently he was recognized by the American College of Emergency Physicians, New York Chapter, receiving the Michael G. Gutenberg Outstanding Contribution of EMS Award. He has several other awards and citations including Hospital and County EMS Leadership, Dispatcher of the Year, Lifesaving and Legislative recognitions for his contributions to the EMS System. Michael retired from the Lagrange Fire District as the EMS Administrator in December 2023. In addition to working as a part-time Ulster County telecommunication he serves as Assistant EMS Coordinator for Ulster County.

PUTTING THE "WHY" INTO CARDIOLOGY

Too often the intricacy and complexity cardiology are condensed into quick memorization techniques like catchphrases and flashcards. While recognition is important, simply identifying a dysrhythmia falls short of the necessary understanding needed to provide optimal patient care. Anyone can memorize a flash card but excellent clinicians understand why events occur. Grasping the root causes and the underlying pathophysiology of change provides not only a lasting procedural memory of cardiology but also affords the ability to anticipate change. We will describe basic electrophysiology leading to ECG changes, the impact of those changes on cardiac mechanics, and introduce the pathophysiology of heart disease that every provider should understand.

SITUATIONAL ACTIVITY AND SUSPICIOUS ACTIVITY REPORTING

Homeland Security Class: This is a new class developed by the New York State Intelligence Center (NYSIC) and the New York State Division of Homeland Security and Emergency Services (DHSES) and delivered by local Intelligence Liaison Officers (ILOs). The purpose of the class is to make Fire/EMS responders better aware of suspicious activities (potentially related to terrorism and other criminal behavior) and the proper way to report these observations to the New York State Terrorism Tips Line.
